ORDER GRANTING TRI-STATE'S MOTION FOR EXTENSION FOR ALL PARTIES (i) TO FILE REPLIES IN SUPPORT OF TRI-STATE'S INITIAL MOTION AND IN OPPOSITION TO ALL RESPONSES FILED THERETO, AND (ii) TO FILE RESPONSES TO THE PUEBLO OF LAGUNA'S MOTION TO STRIKE AFFIDAVITS OF MICHEAL S. MCINNES AND DENNIS R. COOPER AND TRI-STATE'S TYPEWRITTEN TRANSCRIPTIONS

This matter came before the Court and Special Master upon Tri-State's Motion for Extension for All Parties (i) to File Replies in Support of Tri-State's Initial Motion and in Opposition to All Responses Filed Thereto, and (ii) to File Responses to the Pueblo of Laguna's Motion to Strike Affidavits of Micheal S. McInnes and Dennis R. Cooper and Tri-State's Typewritten Transcriptions ("Motion for Extension"). The Special Master having reviewed the Motion for Extension, having considered any responses thereto, having heard oral argument, and being otherwise fully and sufficiently advised in the premises thereof, finds good reason to GRANT the Motion for Extension.

IT IS HEREBY ORDERED that the Motion for Extension be, and hereby is GRANTED, extending the deadline for Tri-State and all other parties (i) to file replies in support of the Initial Motion and in opposition to the Responses, and (ii) to file responses in opposition to Laguna's

Motion to Strike Affidavits, until Monday, September 14, 2009, approximately thirty (30) days after the date expert witness disclosures and reports are due from all Active Parties under the Third Pre-hearing Scheduling Order Governing Subproceeding 1. Further, the Special Master GRANTS Tri-State leave to determine whether it is appropriate to file one consolidated reply to the multiple pleadings filed in response to its Initial Motion, including Laguna's Motion to Strike Affidavits (collectively, "Responses"), or several replies to the Responses depending upon the nature of the Responses.




