SUBPROCEEDING COMPLAINT

The Plaintiff, State of New Mexico, ex rel. the Office of the State Engineer, Thomas C. Turney ("OSE"), by and through undersigned counsel, for its Subproceeding Complaint states:

1. Defendants Pueblo of Acoma and Pueblo of Laguna respectively claim rights to use the waters of the Rio San Jose Stream System within New Mexico.
2. Other Defendants, named and as yet unnamed, undetermined or unknown, assert claims to use waters of the Rio San Jose Stream System.
3. This Court, in its September 23, 2002 Order Granting Joint Motion to Establish A Subproceeding to Adjudicate The Water Rights of Acoma Pueblo and Laguna Pueblo Based on Past and Present Uses of Water ("Subproceeding Order"), ordered adjudication by subproceeding of the respective rights of Acoma Pueblo and Laguna Pueblo based upon past and present uses.
4. All claimants of a right to use water within the Rio San Jose Stream System in New Mexico, whether or not currently joined as parties, and as their identities become known, will be notified of this proceeding pursuant to the notice procedures provided by the Subproceeding Order.


WHEREFORE, PLAINTIFF PRAYS:

A. That this Court determine and adjudicate the respective claims of Acoma Pueblo and the Laguna Pueblo based upon past and present water rights uses within the Rio San Jose Stream System.

B. That this Court allow the joinder of other claimants to waters uses of the Rio San Jose Stream System who desire to participate in the subproceeding in accordance with the procedures and deadlines set by the Court.
