Defendants-Objectors Arsenio Trujillo, Mary Habeeb, Darren Quintana, and Melissa Ortiz have filed objections to the special master’s order denying Defendants’ Arsenio Trujillo’s, Mary Habeeb’s, Darren Quintana’s, and Melissa Ortiz’ motion for summary judgment and granting the State’s motion for summary judgment on March 12, 2014; (Dkt.# 8223, Dkt. # 8233 and Dkt. # 8250) wherein one of the issues is whether the permit issued by the State Engineer pursuant to §72-12-1.1 is property and, if so, in what quantity.

Defendant-Objector's respectfully requests the Court extend the time to file a response to the briefs in support of the settlement agreement until such time as rulings on said objections to the Special Master's orders on motions for summary judgment are filed.
