To connect to the County Water Utility upon transfer of property pursuant to Section 3.1.7.2.3 and 3.1.7.4.3 of the Agreement.



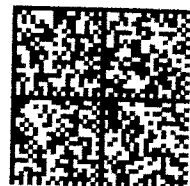
