**MOTION TO ADD OMITTED SOURCE OF WATER
AND POINT OF DIVERSION TO SUBFILE ORDERS
FOR SURFACE WATER RIGHTS SERVED
BY THE CHUPADERO IRRIGATION COMPANY DITCH**

Pursuant to the July 23, 2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909), the State of New Mexico (“State”), by and through its counsel, requests the Court to correct all subfile orders for tracts served by the Chupadero Irrigation Company Ditch by:

- a. identifying the Rio en Medio as a source of water for surface water rights adjudicated under these subfile orders; and
- b. providing the legal description for the point of diversion of the common ditch that conveys surface water from the Rio en Medio to the Rio Chupadero for diversion by downstream ditches including the Chupadero Irrigation Company Ditch.

The State offers the following grounds for this motion:

1. The following subfiles were adjudicated surface water irrigation rights under the Chupadero Irrigation Company Ditch:

15.1, 15.2, 15.2A, 15.3, 15.3A, 15.4, 16.1, 16.1A, 16.2, 16.3, 16.4, 16.5, 16.6, 16.7, 16.8, 16.9, 16.10, 16.10A, 16.10B, 16.10C, 16.11, 16.12, 16.13, 16.14, 16.15, 17.1, 17.2.

2. The Chupadero Irrigation Company Ditch diverts surface water from the Rio Chupadero at a point located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. 8, T. 18N, R. 10E. NMPM. This point of diversion on the Rio Chupadero is identified in the subfile orders entered for the foregoing subfiles.

3. As reflected in the March 19, 1979, Agreement on Water Rights (Doc. 145), the Chupadero Irrigation Company Ditch also receives surface water from the Rio en Medio by means of a common ditch that diverts water from the Rio en Medio to the Rio Chupadero at a location upstream of the Chupadero Irrigation Company Ditch's point of diversion on the Rio Chupadero.

4. The above-referenced subfile orders adjudicated under the Chupadero Irrigation Company Ditch omit reference to the right to receive water from the Rio en Medio.

Accordingly, Section 5.A of each subfile order adjudicated under the Chupadero Irrigation Company Ditch should be corrected to include this omitted information as follows:

The Chupadero Irrigation Company Ditch also receives water from the Rio en Medio through a common ditch which diverts from the Rio en Medio at a point located at X: 425523.65 Y: 3961646.94, NM State Plane Coordinate System NAD 83 UTM, Zone 13N. This water is delivered through the ditch to the Rio Chupadero and flows downstream in the bed of the Rio Chupadero to the Chupadero Irrigation Company Ditch's point of diversion on the Rio Chupadero.

5. The State is serving a copy of this motion and a proposed order granting the motion on all parties or persons who, according to the records of the State, may have an ownership interest in the above-referenced subfiles. The State's proposed order is attached as *Exhibit 1*.

WHEREFORE, the State requests that the Court enter the attached order correcting all subfiles adjudicated under the Chupadero Irrigation Company Ditch to reference the right to receive water from the Rio en Medio as described in paragraph 4 above and in the attached order.
