ORDER GRANTING THE STATE OF NEW MEXICO’S MOTION TO ADD OMITTED  
SOURCE OF WATER AND POINT OF DIVERSION TO SUBFILE ORDERS FOR  
SURFACE WATER RIGHTS SERVED BY THE  
CHUPADERO IRRIGATION COMPANY DITCH

THIS MATTER is before the Court on the State of New Mexico’s *Motion to Add Omitted Source of Water and Point of Diversion to Subfile Orders for Surface Water Rights Served by the Chupadero Irrigation Company Ditch* (Doc. \_\_\_\_, May 28, 2015), filed pursuant to the Court’s July 23, 2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909).

The following subfiles were adjudicated surface water irrigation rights under the Chupadero Irrigation Company Ditch:

- 15.1, 15.2, 15.2A, 15.3, 15.3A, 15.4, 16.1, 16.1A, 16.2, 16.3, 16.4, 16.5, 16.6, 16.7, 16.8, 16.9, 16.10, 16.10A, 16.10B, 16.10C, 16.11, 16.12, 16.13, 16.14, 16.15, 17.1, 17.2.**

As set forth in the State's Motion, the subfile orders for these rights omit reference to the Rio en Medio as an additional source of water for the Chupadero Irrigation Company Ditch. The State therefore requests an order correcting these subfile orders by: (a) identifying the Rio en Medio as an additional source of water; and (b) providing the legal description for the point of diversion of the common ditch that delivers surface water from the Rio en Medio to the Rio Chupadero for use by water rights owners on the Chupadero Irrigation Company Ditch. Having been fully advised in the premises, the Court finds the Motion well taken, and that the State's proposed source of water and point of diversion information should be adopted and added to all subfile orders adjudicated under the Chupadero Irrigation Company Ditch.

IT IS THEREFORE ORDERED that paragraph 5.A of each subfile order adjudicating a surface water irrigation right under the Chupadero Irrigation Company Ditch is hereby corrected to add the following source of water and point of diversion description:

The Chupadero Irrigation Company Ditch also receives water from the Rio en Medio through a common ditch which diverts from the Rio en Medio at a point located at X: 425523.65 Y: 3961646.94, NM State Plane Coordinate System NAD 83 UTM, Zone 13N. This water is delivered through the ditch to the Rio Chupadero and flows downstream in the bed of the Rio Chupadero to the Chupadero Irrigation Company Ditch's point of diversion on the Rio Chupadero.
