**MOTION TO CORRECT SUBFILE ORDER TO ADD OMITTED GROUNDWATER
POINT OF DIVERSION FOR DOMESTIC/LIVESTOCK WELL (SUBFILE NO. 5.13)**

Pursuant to Section A.2 of the July 23, 2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909), the State of New Mexico (“State”), by and through its counsel, requests the Court to enter the attached Order providing the legal description of the groundwater point of diversion (i.e., well location) for a domestic/livestock well, Well No. RG-6026, that was omitted from previous orders entered under Subfile No. 5.13. The State offers the following grounds for this motion:

1. On March 25, 1969, the Court entered an “Order” under Subfile 5.13 adjudicating a groundwater right for domestic and/or livestock use to Gilbert J. Gonzales (“Subfile Order”). The groundwater right and associated well are identified in the Subfile Order as Office of the State Engineer (“OSE”) File No. RG-6026. The Subfile Order omitted a legal

description of the location of Well No. RG-6026, and instead described the point of diversion as “[w]ithin the Jacona Grant.” A copy of the Subfile Order is attached as *Exhibit 1*.

2. Accordingly, Section 5.B of the Subfile Order entered in Subfile No. 5.13 should be corrected to give the complete and accurate legal description of the point of diversion for Well No. RG-6026 as follows:

B. Purpose – Domestic and/or Stock (underground water):

State Engineer File No.: RG-6026

Priority: May 25, 1961

**Point of Diversion: X= 554,631 Y= 1,778,217 on the New Mexico State
Plane Coordinate System, Central Zone, 1927 N.A.D.**

3. Except as requested by this motion, all other elements of the rights adjudicated under Subfile 5.13 should remain as stated in the Subfile Order and subsequent orders of this Court.

4. The State is serving a copy of this motion and a proposed order granting the motion on all parties or persons who, according to the records of the State, may have an ownership interest in Subfile No. 5.13. The State’s proposed order is attached as *Exhibit 2*.

WHEREFORE, the State requests that the Court enter the attached order correcting Section 5.B of the March 25, 1969 Subfile Order entered in Subfile No. 5.13 to give the complete and accurate legal description for the point of diversion of the groundwater right adjudicated for domestic and/or livestock use (Well No. RG-6026) as described in paragraph 2 above.
