**MOTION TO CORRECT SUBFILE ORDER TO ADD OMITTED GROUNDWATER
POINT OF DIVERSION FOR DOMESTIC/LIVESTOCK WELL (SUBFILE NO. 5.18A)**

Pursuant to Section A.2 of the July 23, 2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909), the State of New Mexico (“State”), by and through its counsel, requests the Court to enter the attached Order providing the legal description of the point of diversion (i.e., well location) for the groundwater right adjudicated for domestic and livestock use under Subfile No. 5.18A. The State offers the following grounds for this motion:

1. On May 8, 1968, the Court entered an “Order” under Subfile 5.18A adjudicating a groundwater right for domestic and/or livestock use to Charles Loughdridge (“Subfile Order”). The Subfile Order indicates that the groundwater right was designated by the Office of the State Engineer (“OSE”) as File No. RG-7780. The Subfile Order omitted a legal description of the

location of Well No. RG-7780, and instead described the point of diversion as “[w]ithin the Jacona Grant.” A copy of the Subfile Order is attached as *Exhibit 1*.

2 Subpart B of Paragraph 5 of the Subfile Order entered in Subfile No. 5.18A should be corrected to give legal description of the point of diversion for Well No. RG-7780 as follows:

Purpose: Non NMSA § 72-12-1 and -1.1 Domestic use for One Household and/or Livestock (Groundwater Only)

State Engineer File No.: RG-7780

Priority: 1931

Point of Diversion: X= 554,090 Y= 1,778,060 on the New Mexico State Plane Coordinate System, Central Zone, 1927 N.A.D.

Place of Use: Within the property owned by the Defendant(s) served by the well

Amount of Water: Not to exceed a diversion of 3.0 acre-feet per year from the well described above or the historic beneficial use, whichever is less.

3. Except as requested by this motion, all other elements of the rights adjudicated under Subfile 5.18A should remain as stated in the Subfile Order and subsequent orders of this Court.

4. The State is serving a copy of this motion and a proposed order granting the motion on all parties or persons who, according to the records of the State, may have an ownership interest in Subfile No. 5.18A. The State’s proposed order is attached as *Exhibit 2*.

WHEREFORE, the State requests that the Court enter the attached order correcting Subpart B of Paragraph 5 of the May 8, 1968 Subfile Order entered in Subfile No. 5.18A to give the legal description for the point of diversion of the groundwater right adjudicated for domestic and/or livestock use (Well No. RG-7780) as described in paragraph 2 above.
