**UNOPPOSED MOTION TO VACATE ORDER ADJUDICATING PRE-1982 DOMESTIC  
WELL SUBFILE RG-24657 FOR ERNEST E. TRUJILLO AND IRENE I. TRUJILLO  
AND ENTER REVISED SIGNED CONSENT ORDER**

The State of New Mexico ex rel. State Engineer (“State”) hereby moves the Court to pursuant to Fed. R. Civ. P. 60(b) vacate its January 12, 2016 *Order Adjudicating Pre-1982 Domestic Well Water Rights* (No. 10472), and enter the Consent Order adjudicating the Pre-1982 domestic well water right associated with subfile RG-24657 attached hereto as Exhibit A, and in support thereof, states as follows:

1. On October 27, 2015, the State forwarded to the Court a proposed Order Adjudicating Pre-1982 Domestic Well Water Rights under subfile RG-24657 for Defendants Ernest E. Trujillo and Irene I. Trujillo.

2. The attorney for the State, Edward C. Bagley, correctly certified in that document that the Defendants had not submitted a request for consultation.

3. On January 12, 2016, the Court entered the *Order Adjudicating Pre-1982 Domestic Well Water Rights* (No. 10472). The purpose of use was identified as “Domestic use for One Household.” *Id.*

4. Subsequent to the entry of the *Order*, Defendants contacted the State, and alerted it to the fact that they had been beneficially using a greater amount of water than the *Order* reflected, and for multiple households.

5. The State undertook an investigation of the Defendants’ assertions, and found them to be correct.

6. Defendants and the State have signed a Consent Order adjudicating the Pre-1982 water right under subfile RG-24657 consistent with the above described investigation, and the actual quantity of water beneficially used from the well. The Consent Order is attached hereto as Exhibit A.

7. Contemporaneously with the filing of this Motion, the State will submit the Consent Order to the Special Master.

8. Defendants do not oppose this motion.

WHEREFORE, the State requests that the Court vacate its January 12, 2016 *Order Adjudicating Pre-1982 Domestic Well Water Rights* (No. 10472), and enter the Consent Order adjudicating the pre-1982 domestic well water right associated with subfile RG-24657 attached hereto as Exhibit A.
