**ORDER GRANTING STATE OF NEW MEXICO’S MOTION TO CORRECT 314  
SUBFILE ORDERS SUBJECT TO POST-1982 DOMESTIC WELLS STIPULATION  
AND SETTLEMENT AGREEMENT BY ADOPTING PRIORITY DATES FOR  
DOMESTIC WELLS**

THIS MATTER is before the Court on the State of New Mexico’s *Motion to Correct 314 Subfile Orders Subject to Post-1982 Domestic Wells Stipulation and Settlement Agreement by Adopting Priority Dates for Domestic Wells* (Doc. 10985, November 7, 2016). Having been fully advised in the premises, with no responses opposing the Motion having been filed, the Court finds the State’s Motion is well taken, and that it should be **GRANTED**.
