**NOTICE OF FILING UPDATED SERVICE LIST AS TO ALL KNOWN WATER RIGHTS CLAIMANTS IN THE POJOAQUE BASIN FOR PURPOSES OF PROVIDING NOTICE OF *INTER SE* PROCEEDING**

Pursuant to the September 9, 2016 *Order Granting Plaintiff’s State of New Mexico’s Motion to Establish Procedures for Final Inter Se Proceeding and Entry of a Final Judgment and Decree [Doc. No. 10761]* (Doc. 10849), the State of New Mexico submits the updated service list (“Updated List”) as to all known water rights claimants in the Nambe-Pojoaque-Tesuque stream system (“Pojoaque Basin”). The State will mail the notice of *inter se* proceeding and *inter se* objection form to those identified on the Updated List by first class mail. The Updated List is attached as Exhibit A.

The Updated List includes a list of parties to the adjudication and other known water rights claimants in the Pojoaque Basin, identified from the following sources: (1) existing

hydrographic survey and court records for the adjudication; (2) the public records of the Santa Fe County Assessor; (3) the public records of the State Engineer; (4) the respective public records of irrigation districts, acequias, water conservancy districts and other water users' associations or commissions.

The Updated List was prepared initially using the names and addresses of all parties and claimants in this adjudication identified from 1966 to the present in the adjudication records of the State. To this list, the names and addresses of all surface and groundwater rights owners and permit holders in the Pojoaque Basin available from the Office of the State Engineer Water Administration Technical Engineering Resource System (W.A.T.E.R.S) database were added. Where information was lacking or incomplete, such as a missing zip code or postal code, a zip code was added based upon available information. Any person who attended a public meeting or consulted with the State and provided an address was added to the list.

The State sent letters by first class mail on October 19, 2016 requesting current membership lists, with addresses, to the following ditches: Rincon Ditch, Llano Ditch, Los Gardunos, Barranco Ditch, Cano Ditch, the PVID Board, Otra Banda Ditch, the Ortiz Ditch, the Acequia de Las Joyas, El Rancho Ditch, Los Trujillos, Barranco Alto Ditch, Jose G. Ortiz Ditch, Los Indios Ditch, the Cano Ditch, Comunidad Ditch, La Nueva Ditch, Rincon Ditch, Acequia Del Rio, and Acequia Larga. The State received lists from the Acequia de Los Ortiz, Acequia de la Comunidad, Ancon de Jacona Ditch and Acequia de los Trujillos, which were incorporated into the Updated List.

Pursuant to the Procedural Order, the Updated List identifies all persons entitled to notice, so far as they can be ascertained with reasonable diligence.
