**MOTION TO CORRECT SUBFILE ORDER TO ADOPT PRIORITY DATE FOR
SUPPLEMENTAL GROUNDWATER IRRIGATION WATER RIGHT
(SUBFILE NO. 5.19)**

Pursuant to Section A.2 of the July 23, 2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909), the State of New Mexico (“State”), by and through its counsel, requests the Court to correct the subfile order entered in Subfile No. 5.19 by adopting a December 31, 1945, priority for the supplemental groundwater irrigation water right adjudicated for diversion from a “private well” subsequently designated by the Office of the New Mexico State Engineer (“OSE”) under File No. RG-18390. The State offers the following grounds for this motion:

1. On August 4, 1968, the Court entered an “Order” (“Subfile Order”) in Subfile Nos. 5.19 and 5.19A identifying a “private well” as a groundwater point of diversion for irrigation supplemental to the Acequia Barranco de Jacona of 8.18 acres as shown on

Hydrographic Survey Map Sheet No. 5, Tract 19 (“Tract 5.19”). The Subfile Order, attached as *Exhibit 1*, omitted a priority date for the supplemental groundwater irrigation water right adjudicated for diversion from this well which was later designated under OSE File No. RG-18390.

2. Based upon a 1992 field inspection and meeting with the subfile defendant, R. Lee Aamodt, the State determined that the original well referenced in the subfile order was hand dug in 1945.

3. The State therefore proposes that the Court adopt a December 31, 1945 priority for the supplemental groundwater irrigation water right adjudicated for irrigation of Tract 5.19 from the “private well” referenced in the Subfile Order. The State further proposes that subpart (b) of “Groundwater” under “Point of Diversion” in subpart A.1 of Paragraph 5 of the Subfile Order should be corrected to add the following information regarding the supplemental groundwater irrigation water right associated with the private well:

(b) Private well (RG-18390) located within this tract, in the Jacona Grant.
Priority: 12/31/1945

4. Except as requested by this motion, all other elements of the rights adjudicated under Subfile No. 5.19 should remain as stated in the Subfile Order and subsequent orders of this Court.

5. The State is serving a copy of this motion and a proposed order on all parties or persons who, according to the records of the State, may have an ownership interest in Subfile No. 5.19. The State’s proposed order is attached as *Exhibit 2*.

WHEREFORE, the State requests that the Court enter the attached order correcting the August 4, 1968 Order entered in Subfile No. 5.19 by adopting a December 31, 1945 priority for

the supplemental groundwater irrigation water right adjudicated for diversion from a private well (OSE File No. RG-18390) for irrigation of 8.18 acres as shown on Hydrographic Survey Map Sheet No. 5, Tract 19.
