UNOPPOSED MOTION TO VACATE ORDER ADJUDICATING PRE-1982 DOMESTIC WELL SUBFILE RG-36254 FOR JUANITA M. WIRTH-JACKSON AND ENTER REVISED SIGNED CONSENT ORDER

The State of New Mexico ex rel. State Engineer (“State”) hereby moves the Court to vacate its August 27, 2014 *Order Adjudicating Pre-1982 Domestic Well Water Rights* (No. 9552), and enter the Consent Order adjudicating the Pre-1982 domestic well water right associated with subfile RG-36254 attached hereto as Exhibit A and in support thereof, states as follows:

1. On August 20, 2014, the State forwarded to the Court a proposed Order Adjudicating Pre-1982 Domestic Well Water Rights under subfile RG-36254 for Defendant Juanita Marie Wirth-Jackson.

2. The attorney for the State, Edward Bagley, correctly certified in that document that the Defendant had not submitted a request for consultation.

3. On August 27, 2014, the Court entered the *Order Adjudicating Pre-1982 Domestic Well Water Rights* (No. 9552).

4. Subsequent to the entry of the *Order*, Defendant Juanita Marie Wirth-Jackson contacted the State, and alerted it to the fact that she was beneficially using a greater amount of water than the *Order* reflected.

5. The State undertook an investigation of Defendant's assertions, and found them to be correct.

6. Defendant and the State have both signed a Consent Order adjudicating the Pre-1982 water right under subfile RG-36254 consistent with the above described investigation, and the actual quantity of water beneficially used from the well. The Consent Order is attached hereto as Exhibit A.

7. Contemporaneously with the filing of this Motion, the State will submit the Consent Order to the Special Master.

8. Defendant Juanita Marie Wirth-Jackson does not oppose this motion.

WHEREFORE, the State requests that the Court vacate its August 27, 2014 *Order Adjudicating Pre-1982 Domestic Well Water Rights* (No. 9552), and enter the Consent Order adjudicating the Pre-1982 domestic well water right associated with subfile RG-36254 attached hereto as Exhibit A.
