**[PROPOSED] ORDER GRANTING MOTION TO CORRECT SUBFILE ORDERS FOR
WATER RIGHTS SERVED BY ACEQUIA DEL BARRANCO DE JACONA
TO ADOPT PRIORITY DATE FOR SUPPLEMENTAL GROUNDWATER
IRRIGATION WATER RIGHT ADJUDICATED FOR DIVERSION FROM
COMMUNITY IRRIGATION WELL**

THIS MATTER is before the Court on the State of New Mexico’s (the “State”) *Motion to Correct Subfile Orders for Water Rights Served by the Acequia del Barranco de Jacona to Adopt Priority Date for Supplemental Groundwater Irrigation Water Right Adjudicated for Diversion from Community Irrigation Well* (Doc. _____, _____), filed pursuant to the Court’s July 23,

2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909). Having been fully advised in the premises, the Court finds the State's motion well-taken, and that it should be GRANTED.

IT IS ORDERED, THEREFORE, that an August 13, 1955 priority is adopted for the supplemental groundwater irrigation water right adjudicated for diversion from the Acequia del Barranco de Jacona's community irrigation well, Well No. RG-77627.

IT IS FURTHER ORDERED, that subfile orders entered in Subfile Nos. 5.16, 5.17, 5.17-A, 5.17-B, 5.18, 5.18-A, 5.19, 5.19-A, 5.20, 5.21, 5.22, 5.23, 5.24, 5.25, 5.26, 5.27, 5.27-A, 5.27-B, 5.28, 5.29, 5.30, 5.31, 5.31-A, 5.32, 5.33, 5.34, 5.35, 5.36, 5.37, 6.31-A, 6.60, 6.61, 6.62, 6.63, 6.64, 6.65, 6.66, 6.67, 6.68, 6.69, 6.70, 6.71, 6.72, 6.73, 6.74, 6.75, 6.76, 6.77, 6.78, 6.79, 6.80, 6.81, 6.82, 6.83, 6.84, adjudicating surface water irrigation water rights or "no rights" served by the Acequia del Barranco de Jacona, are hereby corrected to fully describe the supplemental groundwater irrigation water right associated with the community well, Well No. RG-77627, as follows:

Purpose – Irrigation

Groundwater:

State Engineer File No: RG-77627

Priority: August 13, 1955

Point of Diversion: Community irrigation well No. RG-77627
located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 12, T.
19 N, R. 8 E., within the Pojoaque Pueblo
Grant.

Except as expressly corrected by this Order, all elements of the rights adjudicated under the above-referenced subfiles should remain as stated in the subfile orders including, but not limited to, the determination in the subfile orders concerning the right to receive water from the Acequia del Barranco de Jacona's community irrigation well, Well No. RG-77627. Whether a

given subfile tract has the right to receive water from the community irrigation well remains as stated in the subfile order.
