**ORDER GRANTING MOTION TO CORRECT SUBFILE ORDER TO ADOPT  
PRIORITY DATE FOR SUPPLEMENTAL GROUNDWATER IRRIGATION WATER  
RIGHT**

THIS MATTER is before the Court on the State of New Mexico’s (the “State”) *Motion to Correct Subfile Order to Adopt Priority Date for Supplemental Groundwater Irrigation Water Right* (Doc. 10713, June 22, 2016), filed pursuant to the Court’s July 23, 2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909). Having been fully advised in the premises, and with no responses opposing the Motion having been filed, the Court finds the State’s motion well-taken, and that it should be **GRANTED**.


**IT IS ORDERED, THEREFORE,** that a priority of “November 28, 1956, or date the well was completed if earlier” is adopted for the supplemental groundwater irrigation water right

adjudicated for diversion from one or more supplemental groundwater irrigation wells under the following subfiles: 10.38, 16.14, 16.14A, 2.64A, 28.28, 29.5, 29.7, 29.8, 6.21, 6.56 & 6.57, 8.54, 10.82, 16.10C, 16.17C, 16.8, 2.24, 2.27, 27.21B, 27.68A, 6.24, 6.24A, 6.29, 8.22, 7.13, and 2.48.

**IT IS FURTHER ORDERED**, that that the subfile order in each of the foregoing subfiles is corrected by adding the following priority date information under “Groundwater” in the portion of the subfile order describing irrigation water rights:

Priority: November 28, 1956, or date the well was completed if earlier.

Except as expressly corrected by this Order, all elements of the rights adjudicated under the above-referenced subfiles shall remain as stated in the subfile orders and subsequent orders of the Court.
