**MOTION TO CORRECT WELL LOCATION (RG-26187)**

Pursuant to the July 23, 2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909), the State of New Mexico (“State”), by and through its counsel, requests the Court to correct a clerical error in the legal description for the well location contained in the January 31, 1984 order (“Subfile Order”) adjudicating a Section 72-12-1 domestic/livestock well water right under File No. RG-26187. *See* Subfile Order attached as *Exhibit 1*. The correct legal description for Well No. RG-26187 is:

SE ¼ SE ¼ NW ¼, Section 9, Township 19 North, Range 8 East.

The Subfile Order should therefore be corrected as set forth in the proposed order granting the motion attached as *Exhibit 2*. The State is serving a copy of this motion and the proposed order

granting the motion on all parties or persons who, according to the records of the State, may have an ownership interest in the above-referenced subfiles.
