MOTION TO CORRECT WELL LOCATION (SUBFILE NO. 2.13)

Pursuant to the July 23, 2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909), the State of New Mexico (“State”), by and through its counsel, requests the Court to correct a clerical error in the legal description for the well location contained in the March 14, 1968 order (“Subfile Order”) entered in Subfile No. 2.13 adjudicating a pre-basin domestic/livestock well water right. The Subfile Order incorrectly states that domestic/livestock well, designated as Well No. RG-86897 by the Office of the State Engineer, is located in the NW ¼ SE ¼ NW ¼, Section 9, Township 19 North, Range 8 East. The correct legal description for Well No. RG-86897 is:

SW ¼ SE ¼ NW ¼, Section 9, Township 19 North, Range 8 East.

The Subfile Order should therefore be corrected as set forth in the proposed order granting the motion attached as *Exhibit 1*. The State is serving a copy of this motion and the proposed order granting the motion on all parties or persons who, according to the records of the State, may have an ownership interest in the above-referenced subfile.

WHEREFORE, the State requests that the Court enter the attached order correcting the legal description for the domestic/livestock well location (Well No. RG-86897) in the March 14, 1968, Order entered in Subfile No. 2.13.
