MOTION TO CORRECT WELL LOCATION (RG-24144)

Pursuant to the July 23, 2013, *Procedural Order for Correcting Subfile Errors* (Doc. 7909), the State of New Mexico (“State”), by and through its counsel, requests the Court to correct a clerical error in the legal description for the well location contained in the May 20, 1985 order (“Subfile Order”) [Doc. 2563] adjudicating a Section 72-12-1 domestic/livestock well water right under File No. RG-24144. The Subfile Order incorrectly states that Well No. RG-24144 is located in the NE ¼ NE ¼ SE ¼, Section 11, Township 19 North, Range 8 East. The correct legal description for Well No. RG-24144 is:

NE ¼ NE ¼ SE ¼, Section 8, Township 19 North, Range 8 East

The Subfile Order should therefore be corrected as set forth in the proposed order granting the motion attached as *Exhibit 1*. The State is serving a copy of this motion and the proposed order

granting the motion on all parties or persons who, according to the records of the State, may have an ownership interest in the above-referenced subfile.

WHEREFORE, the State requests that the Court enter the attached order correcting the legal description for the well location in the May 20, 1985, order adjudicating a Section 72-12-1 domestic/livestock well water right under File No. RG-24144.
