**ORDER GRANTING MOTION TO VACATE ORDER [DOCKET NO. 10421] AND
CORRECT SUBFILE ORDER TO ADD OMITTED SUPPLEMENTAL
GROUNDWATER IRRIGATION WATER RIGHT (SUBFILE NO. 2.36)**

The Court, having considered the *Motion to Vacate Order [Docket No. 10421] and Correct Subfile Order to Add Omitted Supplemental Groundwater Irrigation Water Right (Subfile No. 2.36)* (Doc. 10560, April 7, 2016) filed by the State of New Mexico (the “State”), with no responses opposing the Motion having been filed, and being otherwise fully advised in the premises, finds that the State’s Motion is well-taken, and that it should be **GRANTED**.


IT IS ORDERED, THEREFORE, that the Court’s *Order Granting Motion to Correct Subfile Order to Add Omitted Supplemental Groundwater Points of Diversion for Irrigation Water Right (Subfile No. 2.36)* [Doc. 10421, December 23, 2015] is vacated.

IT IS FURTHER ORDERED, that Section A of Paragraph 5 of the May 3, 1974, Order entered in Subfile No. 2.36 is corrected as follows to add Well Nos. RG-56157 and RG-56157-X as points of diversion for a supplemental groundwater irrigation water right with a May 31, 1952 priority:

Groundwater: Well No. RG-56157 located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ T. 14N, R. 8E, and
Well No. RG-56157-X located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ T. 14N, R. 8E.

Priority: 5/31/1952

Except as expressly corrected by this Order, all other elements of the rights adjudicated under Subfile No. 2.36 shall remain as stated in the May 3, 1974 Order and subsequent orders of the Court.
