1. My Mom and Dad settled on the referenced property in late 1955 or early 1956.
2. We took possession of the property before the deed was filed, which I believe was in 1958.
3. There were two hand dug wells on the referenced property, one was at the top of the property just north of the house, it had a jet pump and was cased by rocks.
