
**NOTICE CONCERNING INTER SE OBJECTIONS FILED BY  
THE UNITED STATES AND THE PUEBLOS OF NAMBÉ, POJOAQUE,  
SAN ILDEFONSO AND TESUQUE**

Pursuant to Section 7 of the *Order Granting Plaintiff's State of New Mexico's Motion to Establish Procedures for Final Inter Se Proceeding and Entry of a Final Judgment and Decree*, (filed September 9, 2016) (Doc. 10849), at p. 6, the United States and the Pueblos of Nambé, Pojoaque, San Ildefonso and Tesuque ("Pueblos") hereby inform the Court and parties of the following. To the extent that the United States' and Pueblos' objections remain unresolved for non-settling parties or non-responding parties from *Pueblos' Objections to State's Proposed Order to Show Cause* (June 6, 1983) (Doc.724) and *United States' and Pueblos' Amended Objections to Subfile Judgments* (July 12, 1983) (Doc. 758a), the United States and the Pueblos withdraw them and will not pursue them in this case.

To the extent an *inter se* objection was previously filed on the grounds of trespass, the withdrawal of an objection and a determination not to pursue the objection in this action for trespass to water rights based on alleged use of water on Pueblo lands as grounds for the objection, does not waive the right of the United States or any Pueblo to pursue claims of trespass to land in other proceedings.

The United States and the Pueblos will not file any new *inter se* objections.
