**NOTICE OF FIRST MANDATORY FINAL *INTER SE* STATUS CONFERENCE**

THIS MATTER is before the Special Master, entered pursuant to the Order of Reference [Doc. No. 6336], as amended [Doc. No. 7736]. The Court's Order Granting Plaintiff the State of New Mexico's Motion to Establish Procedures for Final *Inter Se* Proceeding and Entry of a Final Judgment and Decree [Doc. No. 10761], entered on September 9, 2016 [Doc. No. 10849], mandated that "[p]ersons who timely file *inter se* objections and the affected subfile parties/defendants shall be required to attend a scheduling conference with the Court in Santa Fe, to be held within 14 days of the deadline for filing objections." *Id.* ¶ D(1). The deadline for filing *inter se* objections was January 24, 2017. The following objections were filed with the Court:

Plaintiff the State of New Mexico and all parties listed herein are hereby required to attend a status conference, either in person or through counsel, on **Tuesday, February 7, 2017 at 2:00 p.m. at the United States Courthouse, South Federal Place, Santa Fe, New Mexico. Telephonic appearances will not be allowed.** This status conference will be on the record.

In many instances those filing *inter se* objections did not identify the subfiles or the parties to which they were raising objections. Therefore, **at this time defendants whose rights are being contested by those filing *inter se* objections are not required to attend the status conference.**

Issues to be discussed at the status conference include:

1. Full and complete identification of all subfiles and parties to which *inter se* objections have been raised, and an explanation of those objections,
2. The scheduling of final *inter se* proceedings as contemplated by the Court's Order of September 9, 2016,
3. The extent of participation, if any, of parties joined in the adjudication after January 11, 2017.
4. Any other matters raised by the parties.

PURSUANT TO THE COURT'S ORDER [DOC. NO. 10849] ANY PARTY WHO FILED AN *INTER SE* OBJECTION AND WHO FAILS TO ATTEND THIS SCHEDULING CONFERENCE WILL BE DEEMED TO HAVE WAIVED ANY *INTER SE* OBJECTION.

**THE PARTIES ARE NOTIFIED THAT WITHIN 14 DAYS OF SERVICE [Doc. No. 10791] of a copy of this order, report, or recommendation, they may file written objections with the Clerk of the Court pursuant to Federal Rule of Civil procedure 53(f)(2). A party must file any objections with the Clerk of the Court within the fourteen day period if that party wants the District Judge to hear their objections. If no objections are filed within the fourteen day period, the District Judge may adopt the order, report of recommendations in whole.**
