2. Mr. Abeita, State of New Mexico Bar No. 148058, is a member of good standing of the Bar of the State of New Mexico.


3. Mr. Abeita, Federal Bar No. 16-270, is a member of good standing of the U.S. District Court for the District of New Mexico.
