ORDER TO SHOW CAUSE

THIS MATTER is before the Special Master, entered pursuant to the Order of Reference [Doc. No. 6336], as amended [Doc. No. 7736]. The Court's Order Granting Plaintiff the State of New Mexico's Motion to Establish Procedures for Final *Inter Se* Proceeding and Entry of a Final Judgment and Decree [Doc. No. 10761], entered on September 9, 2016 [Doc. No. 10849], mandated that "[p]ersons who timely file *inter se* objections and the affected subfile parties/defendants **shall** be required to attend a scheduling conference with the Court in Santa Fe, to be held within 14 days of the deadline for filing objections." *Id.* ¶ D(1) (emphasis added). The Special Master's notice of this status conference, filed on January 25, 2017 [Doc. No. 11304], mandated that any party who

filed an *inter se* objection and who fails to attend the scheduling conference will be deemed to have waived any such objection. No party objected to the Special Master's notice of status conference.

The Special Master held an on-the-record status conference on February 7, 2017. The following persons or parties who had filed *inter se* objections failed to appear: ¹

THE PARTIES ARE NOTIFIED THAT WITHIN 14 DAYS OF SERVICE [Doc. No. 10791] of a copy of this order, report, or recommendation, they may file written objections with the Clerk of the Court pursuant to Federal Rule of Civil procedure 53(f)(2). A party must file any objections with the Clerk of the Court within the fourteen day period if that party wants the District Judge to hear their objections. If no objections are filed within the fourteen day period, the District Judge may adopt the order, report of recommendations in whole.
