**UNOPPOSED MOTION TO DISMISS DEFENDANT PAUL MARK WHITE’S
JANUARY 20, 2017 INTER SE OBJECTION**

The State of New Mexico, *ex rel.* State Engineer (“State”), hereby moves the Court to dismiss Defendant Paul Mark White’s January 20, 2017 *Inter Se Objection* (No. 11280), and in support thereof, states as follows:

1. On September 9, 2016, the Court entered its *Order Granting Plaintiff State of New Mexico’s Motion to Establish Procedures for Final Inter Se Proceeding and Entry of a Final Judgment and Decree* (No. 10849), which described the process for water right owners to object *inter se* to certain water rights adjudicated to other parties.

2. On January 20, 2017, Defendant Paul Mark White timely filed his *Inter Se Objection* (No. 11280), pursuant to the Court's September 9, 2016 *Order*.

3. On March 3, 2017, Defendant e-mailed the State, and indicated he no longer wished to pursue his *Inter Se* objection. See March 3, 2017 e-mail from Defendant Paul Mark White, attached hereto as Exhibit A.

4. Defendant Paul Mark White does not object to this Motion.
