**UNOPPOSED MOTION TO DISMISS DEFENDANTS  
MUSTAPHA KAMEL ABOUDA’S AND TANA BEVERWYK-ABOUDA’S  
TWO (2) JANUARY 24, 2017 INTER SE OBJECTIONS**

The State of New Mexico *ex rel.* State Engineer (“State”), hereby moves the Court to dismiss Defendants Mustapha Kamel Abouda’s and Tana Beverwyk-Abouda’s (“the Aboudas”) two (2) January 24, 2017 *Inter Se Objections* (Nos. 11293 and 11296), and in support thereof, states as follows:

1. On September 9, 2016, the Court entered its *Order Granting Plaintiff State of New Mexico’s Motion to Establish Procedures for Final Inter Se Proceeding and Entry of a*

*Final Judgment and Decree* (No. 10849), which described the process for water right owners to object *inter se* to certain water rights adjudicated to other parties.

2. On January 24, 2017, Defendants the Aboudas timely filed two (2) *Inter Se Objections* (Nos. 11293 and 11296), pursuant to the Court's September 9, 2016 *Order*.

3. On February 24, 2017, Defendants met in face-to-face consultation with the State, and indicated they no longer wished to pursue their two (2) *Inter Se* objections.

4. Defendants the Aboudas do not object to this Motion.

WHEREFORE, the State of New Mexico, *ex rel.* State Engineer ("State"), hereby moves the Court to dismiss Defendants Mustapha Kamel Abouda's and Tana Beverwyk-Abouda's two (2) January 24, 2017 *Inter Se Objections* (Nos. 11293 and 11296).
