**UNOPPOSED MOTION TO DISMISS DEFENDANT
JESSICA A. TRUJILLO’S JANUARY 25, 2017 INTER SE OBJECTION**

The State of New Mexico *ex rel.* State Engineer (“State”), hereby moves the Court to dismiss Defendant Jessica A. Trujillo’s January 25, 2017 *Inter Se Objection* (No. 11303), and in support thereof, states as follows:

1. On September 9, 2016, the Court entered its *Order Granting Plaintiff State of New Mexico’s Motion to Establish Procedures for Final Inter Se Proceeding and Entry of a Final Judgment and Decree* (No. 10849), which described the process for water right owners to object *inter se* to certain water rights adjudicated to other parties.

2. On January 25, 2017, Defendant Jessica A. Trujillo filed her *Inter Se Objection* (No. 11303), pursuant to the Court's September 9, 2016 *Order*.

3. On February 9, 2017, Defendant met in face-to-face consultation with the State, and indicated she no longer wished to pursue her *Inter Se* objection.

4. Defendant Jessica A. Trujillo does not object to this Motion.
