**UNOPPOSED MOTION TO DISMISS DEFENDANTS GERALD D. VASILIK’S AND MARSHA M. ROYBAL’S TWO (2) JANUARY 23, 2017 INTER SE OBJECTIONS**

The State of New Mexico *ex rel.* State Engineer (“State”), hereby moves the Court to dismiss Defendants Gerald D. Vasilik’s and Marsh M. Roybal’s two (2) January 23, 2017 *Inter Se Objections* (Nos. 11283 and 11285), and in support thereof, states as follows:

1. On September 9, 2016, the Court entered its *Order Granting Plaintiff State of New Mexico’s Motion to Establish Procedures for Final Inter Se Proceeding and Entry of a Final Judgment and Decree* (No. 10849), which described the process for water right owners to object *inter se* to certain water rights adjudicated to other parties.

2. On January 23, 2017, Defendants Gerald D. Vasilik and Marsha M. Roybal filed their *Inter Se Objections* (Nos. 11283 and 11285), pursuant to the Court's September 9, 2016 *Order*.

3. On February 22, 2017, subsequent to a face-to-face consultation with the State, Defendants communicated telephonically with the State, and indicated they no longer wished to pursue their *Inter Se* objection.

4. Defendants Gerald D. Vasilik and Marsha M. Roybal do not object to this Motion.

WHEREFORE, the State of New Mexico, *ex rel.* State Engineer ("State"), hereby moves the Court to dismiss Defendants Gerald D. Vasilik's and Marsh M. Roybal's two (2) January 23, 2017 *Inter Se Objections* (Nos. 11283 and 11285).
