**ORDER GRANTING UNOPPOSED MOTION TO DISMISS DEFENDANT  
JESSICA TRUJILLO'S  
JANUARY 25, 2017 INTER SE OBJECTION [DOC. NO. 11418]**

THIS MATTER having come before the Special Master, entered pursuant to the Order of Reference [Doc. No. 6336], as amended [Doc. No. 7736]. In its Order of Reference, the Court directed the Special Master to “hear and determine all claims and contentions of the parties... relating to...the final *inter se* phase of this adjudication.” Order of Reference at 4.

On March 9, 2017 Plaintiff the State of New Mexico filed its *Unopposed Motion to Dismiss Defendant Jessica Trujillo's January 20, 2017 Inter Se Objection* [Doc. No. 11418]. The Court, having reviewed the motion and otherwise being fully advised in the premises, hereby: **FINDS** the motion is well taken and

**ORDERS** that the State's *Motion* is granted, and the Defendant's January 25, 2017 *Inter Se Objection* [Doc. No. 11303] is hereby dismissed with prejudice.

No. 10791] of a copy of this order, report, or recommendation, they may file written objections with the Clerk of the Court pursuant to Federal Rule of Civil procedure 53(f)(2). A party must file any objections with the Clerk of the Court within the fourteen day period if that party wants the District Judge to hear their objections. If no objections are filed within the fourteen day period, the District Judge may adopt the order, report of recommendations in whole.**
