UNOPPOSED MOTION TO DISMISS DEFENDANTS LORENZO MEDINA’S AND PATRICIA MEDINA’S TWO (2) JANUARY 24, 2017 INTER SE OBJECTIONS

The State of New Mexico *ex rel.* State Engineer (“State”), hereby moves the Court to dismiss Defendants Lorenzo Medina’s and Patricia Medina’s two (2) January 24, 2017 *Inter Se Objections* (Nos. 11300 and 11301), and in support thereof, states as follows:

1. On September 9, 2016, the Court entered its *Order Granting Plaintiff State of New Mexico’s Motion to Establish Procedures for Final Inter Se Proceeding and Entry of a Final Judgment and Decree* (No. 10849), which described the process for water right owners to object *inter se* to certain water rights adjudicated to other parties.

2. On January 24, 2017, Defendants Lorenzo Medina and Patricia Medina filed their *Inter Se Objections* (Nos. 11300 and 11301), pursuant to the Court's September 9, 2016 *Order*.

3. On March 22, 2017, subsequent to a telephonic consultation with the State, Defendants communicated telephonically with the State, and indicated they no longer wished to pursue their *Inter Se* objections.

4. Defendants Lorenzo Medina and Patricia Medina do not object to this Motion.

WHEREFORE, the State of New Mexico, *ex rel.* State Engineer ("State"), hereby moves the Court to dismiss Defendants Lorenzo Medina's and Patricia Medina's two (2) January 24, 2017 *Inter Se Objections* (Nos. 11300 and 11301).
