**UNOPPOSED MOTION TO DISMISS DEFENDANT GILBERT P. LUJAN’S JANUARY
9, 2017 INTER SE OBJECTION**

The State of New Mexico *ex rel.* State Engineer (“State”), hereby moves the Court to dismiss Defendant Gilbert P. Lujan’s January 9, 2017 *Inter Se Objection* (No. 11228), and in support thereof, states as follows:

1. On September 9, 2016, the Court entered its *Order Granting Plaintiff State of New Mexico’s Motion to Establish Procedures for Final Inter Se Proceeding and Entry of a Final Judgment and Decree* (No. 10849), which described the process for water right owners to object *inter se* to certain water rights adjudicated to other parties.

2. On January 9, 2017, Defendant Gilbert P. Lujan filed his *Inter Se Objection* (No. 11228), pursuant to the Court's September 9, 2016 *Order*.

3. On March 28, 2017, subsequent to face-to-face and telephonic consultations with the State, Defendant communicated with the State telephonically, and indicated he no longer wished to pursue his *Inter Se* objection.

4. Defendant Gilbert P. Lujan does not object to this Motion.
