**ORDER GRANTING UNOPPOSED MOTION TO DISMISS DEFENDANT
GILBERT LUJAN’S JANUARY 9, 2017 INTER SE OBJECTION [DOC. NO.
11445]**

THIS MATTER having come before the Special Master, entered pursuant to the Order of Reference [Doc. No. 6336], as amended [Doc. No. 7736]. In its Order of Reference, the Court directed the Special Master to “hear and determine all claims and contentions of the parties... relating to...the final *inter se* phase of this adjudication.” Order of Reference at 4.

On March 28, 2017 Plaintiff the State of New Mexico filed its *Unopposed Motion to Dismiss Defendant Gilbert Lujan’s January 9, 2017 Inter Se Objection* [Doc. No. 11445]. The Court, having reviewed the motion and otherwise being fully advised in the premises, hereby: **FINDS** the motion is well taken and

ORDERS that the State's *Motion* is granted, and the Defendant's January 9, 2017

Inter Se Objection (No. 11228) is dismissed with prejudice.

If no objections are filed within the fourteen day period, the District Judge may adopt the order, report of recommendations in whole.
