UNOPPOSED MOTION TO AMEND THE FEBRUARY 1, 2017 ORDER GRANTING UNOPPOSED MOTION TO AMEND THE ORDERS ADJUDICATING SIX (6) PRE-1982 DOMESTIC WELL WATER RIGHTS FROM DOMESTIC USE FOR ONE HOUSEHOLD TO DOMESTIC USE FOR MULTIPLE HOUSEHOLDS TO CHANGE THE SPELLING OF “STAMPHER” TO “STAMPFER” FOR SUBFILE RG-29033

The State of New Mexico ex rel. State Engineer (“State”) hereby moves the Court to, pursuant to Fed. R. Civ. P. 60(b), to amend the February 1, 2017 *Order Granting Unopposed Motion to Amend the Orders Adjudicating Six (6) Pre-1982 Domestic Well Water Rights From Domestic Use for One Household to Domestic Use for Multiple Households* (No. 11315) to change the spelling of “Stampher” for subfile RG-29033 on page two of the *Order* to “Stampfer.”

1. On November 4, 2016, the State filed its *Unopposed Motion to Amend the Orders Adjudicating Six (6) Pre-1982 Domestic Well Water Rights From Domestic Use for One Household to Domestic Use for Multiple Households* (No. 10984).

2. In paragraph 1, on page 2 of the *Motion*, the State misspelled the last name of the owner of the water right under subfile RG-29033 as “Stampher.”

3. The correct spelling of the last name of the owner of the water right under subfile RG-29033 is “Stampfer.”

4. The State made the same spelling error in the proposed Order it forwarded to the Court.

5. Because of the State’s error, the *Order* entered by the Court on February 1, 2017 granting the State’s *Motion* contained the incorrect spelling of Mr. Stampfer’s name. .

8. Counsel for Defendant J. Frederick Stampfer, Jr. does not oppose this motion.

WHEREFORE, the State requests that the Court amend amend the February 1, 2017 *Order Granting Unopposed Motion to Amend the Orders Adjudicating Six (6) Pre-1982 Domestic Well Water Rights From Domestic Use for One Household to Domestic Use for Multiple Households* (No. 11315) to change the incorrect spelling of “Stampher” for subfile RG-29033 on page two of the *Order* to the correct spelling of “Stampfer.”
