**UNOPPOSED MOTION TO DISMISS DEFENDANTS  
MARIETTA L. ROYBAL’S AND VICTORIA M. ROYBAL’S  
TWO INTER SE OBJECTIONS**

The State of New Mexico *ex rel.* State Engineer (“State”), hereby moves the Court to dismiss Defendants Marietta L. Roybal’s and Victoria M. Roybal’s (“the Roybals”) January 12, 2017 and January 17, 2017 *Inter Se Objections* (Nos. 11267 and 11271), and in support thereof, states as follows:

1. On September 9, 2016, the Court entered its *Order Granting Plaintiff State of New Mexico’s Motion to Establish Procedures for Final Inter Se Proceeding and Entry of a*

*Final Judgment and Decree* (No. 10849), which described the process for water right owners to object *inter se* to certain water rights adjudicated to other parties.

2. On January 12, 2017 and January 17, 2017, Defendants the Roybals timely filed two (2) *Inter Se Objections* (Nos. 11267 and 11271), pursuant to the Court's September 9, 2016 *Order*.

3. On March 17, 2017, Defendants met in face-to-face consultation with the State, and indicated they no longer wished to pursue their two (2) *Inter Se* objections.

4. Defendants the Roybals do not object to this Motion.
