ORDER GRANTING UNOPPOSED MOTION TO DISMISS DEFENDANTS
MARIETTA L. ROYBAL’S AND VICTORIA M. ROYBAL’S
TWO INTER SE OBJECTIONS [DOC. NO. 11498]

THIS MATTER having come before the Special Master, entered pursuant to the Order of Reference [Doc. No. 6336], as amended [Doc. No. 7736]. In its Order of Reference, the Court directed the Special Master to “hear and determine all claims and contentions of the parties... relating to...the final *inter se* phase of this adjudication.” Order of Reference at 4.

On May 19, 2017, Plaintiff the State of New Mexico’s filed its *Unopposed Motion to Dismiss Defendants Marietta L. Roybal’s and Victoria M. Roybal’s Two Inter Se Objections* [Doc. No. 11498]. The Court, having reviewed the motion and otherwise being fully advised in the premises, hereby: **FINDS** the motion is well taken and

ORDERS that the State's *Motion* is granted, and the Defendants Marietta M Roybal's and Victoria M. Roybal's January 12, 2017 and January 17, 2017 *Inter Se Objections* (Nos. 11267 and 11271) are dismissed with prejudice.

THE PARTIES ARE NOTIFIED THAT WITHIN 14 DAYS OF SERVICE [Doc. No. 10791] of a copy of this order, report, or recommendation, they may file written objections with the Clerk of the Court pursuant to Federal Rule of Civil procedure 53(f)(2). A party must file any objections with the Clerk of the Court within the fourteen day period if that party wants the District Judge to hear their objections. If no objections are filed within the fourteen day period, the District Judge may adopt the order, report of recommendations in whole.
