ORDER GRANTING DEFAULT JUDGMENT



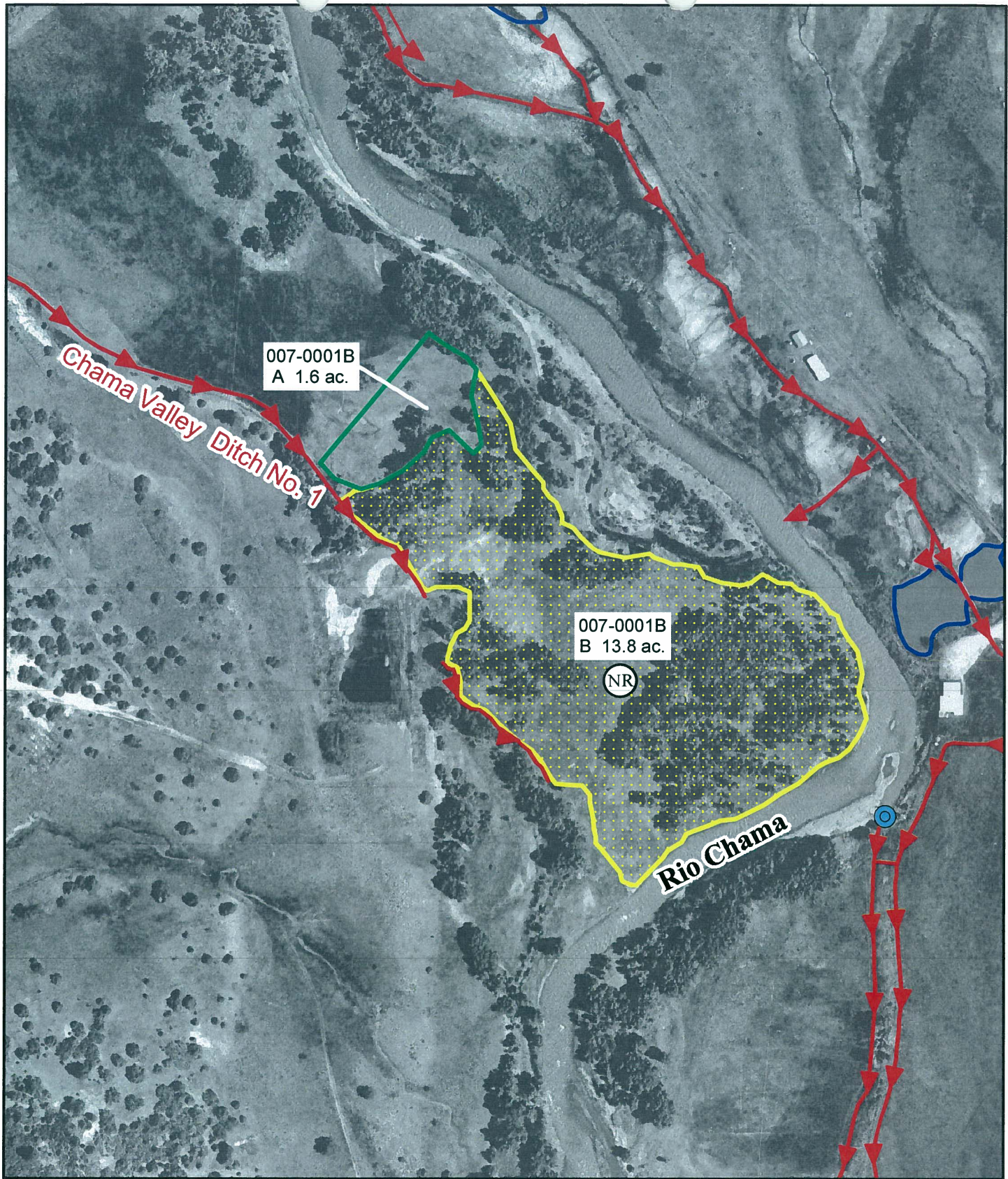
